ORDER:

Government have sanctioned (a) 143 road works of widening from single lane to double lane connecting Mandal Head quarters to District Head quarters in 149 Mandals for Rs. 2585.00 Crores vide G.O. 1st read above (b) 260 road works of widening from single lane to double lane for a length of 2720 km for an amount of Rs. 3704.32 Crores vide G.O. 2nd read above and (c) construction /widening/reconstruction of 389 Bridges in place of Dilapidated Bridges and at un bridged crossings for an amount of Rs. 1974.43 Crores vide G.O. 3rd read above. These works are to be completed in a span of 3 years.

- 4th above, 2. In the reference read the Engineer-in-Chief(R&B)S.R&CRN, Hyderabad has stated that value each work (792 No's) works ranges from Rs. 1.00 crores to Rs 193.00 crores. There are 225 no's of works for which the value ranges from Rs. 1 cr to Rs. 10 Cr, 353 No's of works which ranges from Rs. 10 Cr to 25 Cr, 171 No's of works which ranges from Rs. 25 Cr to Rs. 50 Cr and 43 No's of works are above Rs. 50 Cr. To have the up graduation work like widening & strengthening in to proper line and grade, It is essential that latest machinery like batch mix plant, Hydrostatic controlled Sensor Paver, Graders, Pneumatic tyred rollers and Concrete Batching Plant are required to be deployed. Further, the deployment of the above Plant & Machinery entail initial capital cost and for small works leads below Rs. 50.00 Cr, it may not be workable to deploy the above. Therefore, it would be better to club the works sanctioned in to packages, costing between Rs. 50.00 Cr to Rs. 100.00 Cr.
- **3.** In the reference 5th read above, the Builders association of India, Telangana State, Hyderabad has stated that experienced contractors, latest machinery as per the MORTH specification are essential for completing the above works within stipulated time ensuring good quality. To achieve this and to attract reputed agencies which are well established, it is necessary to get smaller value of works in to convenient packages ranging between to Rs. 50.00 Cr to Rs. 100.00 Cr depending upon the locations and field conditions. However if these works are clubbed and formed into packages of Rs.50.00 crores and above then most of the local contractors would not be eligible for participating in the bidding. Therefore it is required that eligibility criteria in the tender document needs to be modified in accordance the present requirements in addition these modification increases competition among the contractors ensuring saving to the Government exchequer.
- **4.** In the reference 6th read above, the Engineer-in-Chief(R&B)S.R&CRN,Hyderabad has informed that, he has examined the representation of association, it has fact that clubbing of sanctioned works is essential and to overcome the problems raised by the Builders Association, hence he has requested the Government to modify the bid conditions, in view of the encouraging more competition from the agencies and to get the works completed within the stipulated time ensuing the quality in relaxation of the G.O.Ms.No.94, I&CAD Department Dt.01.07.2003.

5. In the circumstances reported by the Engineer-in-Chief(R&B)State Roads & CRN, Hyderabad, in the letters 4^{th} and 6^{th} read above, Government after careful examination of the matter, hereby modify the following Tender conditions, in relaxation to G.O.Ms.No.94, I&CAD Department Dt.01.07.2003, for the works sanctioned in the G.O's 1^{st} , 2^{nd} and 3^{rd} read above.

Qualification:

- **A.** To qualify for award of the Contract, each bidder in its name should have, during the last five years(specified financial years i.e they should be immediately preceding the financial year in which tenders are invited)
 - **a.** Satisfactorily completed as prime contractor, similar works of value not less than Rs. /-@(usually not less than 25% of Estimated value of contract) in any one year.
 - **b.** Executed in any one year, the following minimum quantities of works
 - Cement concrete including RCC and PSC Cum
 - Earth work in both exaction and Embankement Cum
 - (relevant principal items be indicated)
 - (usually 25 percent of the expected peak quantities of construction per year)

BID CAPACITY:

a) The sub contrators's/ GPA holder's experience shall not be taken into account in determining the bidders compliances with the qualifying criteria. The tenders who meet the requirement qualification criteria will be qualified only if their available bid capacity is more than the estimated value. The available bid capacity will be calculated as under Assessed Available Bid Capacity: A x N x 4- B

Where

- A= Maximum value of civil engineering works executed in any one year durin g thelast five years (updated * price level) taking into account the completed as well as works in progress.
- N= Number of years prescribed for completion of the works for which tenders are invited.
- B= Value of existing commitments and ongoing works to be completed durin g theperiod of completion of works for which tenders are invited
- **6.** The Engineer-in-Chief(R&B)S.R, CRN&Jt.M.D,APRDC, Hyderabad shall take further necessary action in the matter accordingly.
- **7.** This order issues with the concurrence of Finance (EBS.X) Dept., vide their U.O.No.5183/127/A1/EBS.X, Dt.23/04/2015.
