ORDER:

In the reference read above, the Commissioner, Greater Hyderabad Municipal Corporation, Hyderabad has informed that; during review meeting held on 09.02.2017 on 2 BHK Housing scheme taken up in GHMC, it was decided for constituting a Technical-cum-Tender Committee for expeditiously finalizing the tenders of 2 BHK housing scheme in GHMC, where the estimated cost is more than Rs.10.00 crores duly issuing amendment to G.O.Ms.No.12, Irrigation & CAD (Reforms) Department, Dated:21.01.2015. He has therefore requested the Government to constitute the Technical cum Tender committee for finalizing 2 BHK Housing / Infra tenders for GHMC in two stages i.e., 1) Approval of technical bids for opening price bids, and 2) Approval of financial bids (tenders), where the estimated cost is more than Rs.10.00 Cr.
