ORDER:

Government of Andhra Pradesh is implementing eProcurement project as a core eGovernance initiative and is successfully in operation since 2002 without any interruption. Government of Andhra Pradesh has felt that the technology of the existing eProcurement is obsolete and need for the new version of eProcurement and eAuction system suitable for all types of procurement requirements which is to be owned by the Government of Andhra Pradesh.

2. The Information Technology, Electronics & Communications Department (Nodal Agency for eProcurement) initiated the process for identification of the developer for the “Development of new version of eProcurement & eAuction system” and the tender has been finalized during the Steering Committee meeting held on 13-5-2013. APTS has signed the contract agreement for the “Development of new version of eProcurement & eAuction system” on 12.02.2014.

3. The Steering Committee advised to create a committee involving all stakeholders during the project development phase so as to create an application by using open standards, latest technology & ensuring the coverage of all functionalities as listed in the RFP document. Therefore, all major departments were requested to nominate a senior officer to the proposed committee. Accordingly nominations were received.

4. In order to guide and coordinate the “Development of new version of eProcurement system”, it is decided to constitute a committee with the following composition along with the received nominations.

- i. The Secretary to Government, IT,E&C Department - Chairperson.
- ii. The Managing Director, APTS - Member .
- iii. The Director (C), IT,E&C Department - Member.
- iv. The Engineer-in-Chief (Public Health) – MA&UD Dept - Member.
- v. The Chief Engineer, I&CAD (Medium) Department - Member.
- vi. The Chief Controller of Stores, APSRTC - Member.
- vii. The Project Manager (eProc), IT,E&C Dept - Member Convener.
- viii. Head, SeMT, IT,E&C Department – Member.
- ix. The Superintending Engineer – APMSIDC - Member.

- x. The Superintending Engineer, Rural Circle, R&B, Hyd – Member.
- xi. Representative from PR&RD Department - Member.
- xii. Representative from Social Welfare Department - Member.
- xiii. Representative from APTS - Member.
- xiv. The Project Manager, ERP – SCCL - Member.
- xv. The Divisional Engineer / P&MM – APTRANSCO - Member.
- xvi. The Divisional Engineer / Computers – APGENCO - Member.

5. The Committee would be responsible for

- Overall supervision of the project.
- Co-ordination among respective departments and to observe the procurement needs are fulfilled.
- Guidance for the development of new version of eProcurement and also handling the issues that arises in the course of development of the project.
- To study and examine the RFP and see that the Government of Andhra Pradesh requirements are full filled.
- To ensure that the functionalities and procurement requirements of the Government of Andhra Pradesh procurement process are achieved.

6. The committee shall meet once in fortnight to review the progress and guide the process of development of eProcurement application according to the Government of Andhra Pradesh requirements.
